Dear Chairman Capito and Ranking Member Coons:

As individuals and businesses that have obtained critically needed financing from a community development financial institutions (CDFIs) Opportunity Finance Network (OFN) member, we are writing to encourage you to set funding for the CDFI Fund at \$250 million in the FY 2018 appropriations bill you are developing.

We are very concerned about the adverse impact that will occur if funding for the CDFI Fund sustains a reduction of more than 20 percent, as proposed in the House version of the FY 2018 Financial Services and General Government appropriations bill. While grateful that funding for the CDFI Fund was not zeroed out in the House as proposed by the Administration, the current level of funding is insufficient to meet the current demand. For example, in FY 2016 the CDFI Fund received Financial Assistance applications from 361 community-based lenders requesting nearly \$547 million in funding. Through a competitive selection process, the CDFI Fund awarded \$144 million to 123 organizations nationwide.

As you consider how much to allocate for this vital program to the CDFI industry, please note that for every \$1 in CDFI Fund awards, CDFIs generate \$12 in financing to communities and residents left out of the economic mainstream. Growth and prosperity cannot be accomplished in places where capital does not flow, especially for rural and Native communities. The strategy employed by CDFIs and the CDFI Fund is market-driven. CDFIs provide access to capital, as well as non-financial resources like training and technical assistance that traditional financial institutions often do not offer. We are great examples of a system that works.

While we recognize the balancing you must do as you allocate funds to various programs, we ask that you maintain the current funding level for the CDFI Fund. A Senate figure well above the House level will help stave off the significant cuts faced by the CDFI Fund and will do more to generate economic development in areas left behind by economic growth in the past few years.
